

## Cabins

Memorial Day through Labor Day cabins rent for one week and reservations can be made up to 11 months in advance. Rentals for four days or more during this period can only be made 90 to 30 days in advance, based on availability. Rentals for a minimum of two nights can be made within 30 days of arrival date. Two night minimum rentals can be made up to 11 months in advance outside of the Memorial Day to Labor Day weekend period. Check-in time is 4 p.m. and check out time is 10 a.m. All cabins have kitchens except Chestnut, Sycamore & Hickory. These cabins are set up for outdoor grilling and have a grill on the porch. Cabin furnishings and equipment include rustic furniture, microwave, coffee maker, refrigerator, range, dishes, cooking utensils, & silverware. Linens are not provided.

Cabins #1-5 are rustic log cabins built by the Civilian Conservation Corp in the early 1930's. Cabins #6-13 are frame cabins with wooden walls and wooden floors. Cabins #14-25 are block cabins with cinder block walls and tile floors. All of these cabins have fireplaces.

Hickory, Sycamore and Chestnut cabins have bedding for eight people. Sycamore cabin has a dormitory style refrigerator, microware, and coffee maker. Sycamore has two bedrooms with two sets of bunk beds with a bathroom in each room. Hickory cabin has two bedrooms with two sets of bunk beds and a common bathroom with three sinks, two showers, one toilet and a full size refrigerator. Chestnut cabin has four bedrooms with two single beds per room, two bathrooms, full size refrigerator, microware, and coffee maker. Red Oak, White Oak and Scarlet Oak are set up like a two bedroom cabin. The three Oaks each have two bathrooms. All of these cabins with names do not have fireplaces.

The CCC Group Lodge is a fully furnished facility. It can sleep up to 15 people. It has six bedrooms and three bathrooms. Bedding arrangements are three queen beds, one double bed, one single and three sets of bunk beds. This facility has a TV with DVD player only, washer, dryer and dishwasher.
