5. NLC Rep report (Tom Benzing)

I. Summary of my recent activities

This month, I participated in three NLC meetings. I learned more about my role as the NLC representative to facilitate communication among national, council, and chapters. At the national level, two changes of note are the new branding tagline, "Every River Needs a Champion" and the renaming of Volunteer Operations to the Engagement Department.

A slate of nominees for Grassroots Trustee positions was approved at the NLC Business Meeting on June 17. The nominees are Linn Beck (WI), Steve Miller (WA), and Gene Slusher (KY) and the slate will be voted on in September. During the same meeting, Beverly Smith (Director, Engagement Department) provided a preliminary summary of annual reports provided by TU chapters last month. Her staff are reviewing these reports and will provide a final summary as well as "state impact reports" within the next few months. In her preliminary summary, Beverly reported a total of 645,191 volunteer hours (with a median of 1,099 hours per chapter) in the annual reports. This number of volunteer hours equates to 310 full-time

employees meaning our volunteer efforts roughly "double our workforce".

As I wrote in my NLC report for May, the National Conservation Agenda (NCA) is currently in a comment period. On August 12, a virtual Town Hall meeting is scheduled to discuss the draft NCA and post questions. If your chapter has comments or questions, please send them to me at benzintr@jmu.edu. 6. TIC report (Mike Makufka)

- By all accounts from the TIC Coordinators, this was a very good year for TIC.
 There were very few schools that encountered total fish loss and at least 12 schools that released over 100 fish.
- The TC Energy grant is being used by chapters. Just recently, the Northern Virginia Chapter requested mileage reimbursement for their volunteers to travel to the release site and to help with macros and casting demonstrations. That chapter's 16 volunteers logged 6,899 miles. At \$.14/mile, that was \$965.86. The new TC Energy grant remaining balance is \$12,080.32. The Smith River Chapter is putting together the numbers for mileage reimbursement as well.
- I am preparing a final report for DWR. I am waiting for the report from Massanutten Chapter and the New River Valley Chapter.
- I have several teachers reaching out to start a new program in the fall. One of the schools is in Leesburg which is on the border of NOVA and Winchester Chapters. We are working on that.
- I sent information to Scott Allen and Blaine Emory (from the Mountain Empire) the last list I had of schools in that chapter's program. It will be interesting to see where that leads us.
