    - Postponed the 2024 TU annual meeting CX3 (Coldwater, Conservation, Community) until sometime in 2025
    - TU will hold an NLC meeting in September 2024 to comply with TU Bylaws
  - 2. 2024 Organizational Priorities Chris Wood, Chairman and Chief Executive Officer
    - Complimented the TU grassroots efforts in 2023 citing a Virginia project
    - Provided three focus areas where the NLC can contribute in 2024
      - 1) Engage members, partners and communities in our conservation work and citizen science
      - 2) Membership recruitment
      - 3) Membership retention
  - 3. Embrace-A-Stream Jeff Yates, Senior Director of Engagement and Ron Rhodes, EAS Committee Chair
    - NLC is responsible for electing EAS members
    - NLC nominated and voted for two new EAS members
      - 1) Southeast Jeff Durniak, Cleveland GA; VA Tech graduate and fisheries biologist
      - 2)Southwest William Finney, Reno, NV; Lt Colonel Army retiree, and career in healthcare management and community service
  - 4. NLC Assessment Survey Results John Bunker, Chair, NLC Grassroots Workgroup
    - The NLC Assessment Survey was distributed to TU leaders from November 7th and December 1st.
    - John briefed on the 2023 NLC survey data and comparison to the 2014 NLC Self-Assessment Survey. The survey will be analyzed with the help of the University of New Hampshire. Rich Thomas, Chair NLC, will update the TU Board of Trustees in February. The 2023 survey results final report will be distributed to TU staff, NLC, Councils and Chapters at a time to be determined. The NLC will prioritize recommendations and develop an action plan.

9. Wildlife Crossings Pilot Program (Amy Orr)

As part of a \$350 million USDOT grant for a Wildlife Crossings Pilot Program, VDOT recently received around \$604,000 to begin work. The grant came about as the number of large animal and vehicle collisions are increasing, and Virginia recently had the 9th highest number reported annually to insurance companies in the US, affecting about 1 in 78 Virginians.

VDOT is working with DWR, DCR and the Department of Forestry across the state. Loudoun County was chosen by DWR as the first in Virginia to have a pilot program to study where the most animal road crossing fatalities occur, and to recommend projects. Jordan Green, VA DWR Resources District Biologist, is working with William and Mary students, after problem areas are identified, to then reach out to local organizations to do the weekly monitoring. The Loudoun year-long study began in November and is being performed by volunteers from Loudoun Wildlife Conservancy and the local Virginia Master Naturalist chapter. Green hopes to start programs in other counties next year.

Monitors use an interactive ArcGIS application to pinpoint locations across Loudoun County on both Route 15 and Route 7 on a weekly basis. Data is uploaded within 5 minutes and information is collected on several animal species (deer, bear, raccoon, opossum, groundhog, fox, skunk, coyote, rabbit, squirrel, turtle, hawk/owl, vulture, others).
